

## Official Rules for the 25<sup>th</sup> Anniversary Grand Getaway Drawing (the “Promotion”)

**The Promotion will take place at Turning Stone Resort Casino between July 25, 2018 and August 25, 2018. One drawing will be held by August 27, 2018 where 10 finalists will be randomly drawn to participate in a final live random drawing at Turning Stone on August 29, 2018. By participating you agree to these official rules. Void where prohibited by law.**

**Eligibility.** Participation is open to guests who are at least 18 years old as of date of entry. Participants must have a TS Rewards card to be eligible. Employees, officers and directors of Turning Stone and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

**How to Enter.** Eligible participants are automatically entered into the Promotion when they make a purchase using their TS Rewards Card, which includes redeeming a Turning Stone voucher, between 12:00 a.m. ET July 25, 2018 and 11:59 p.m. ET on August 25, 2018 at the following participating Oneida Nation businesses: Turning Stone Resort Casino, Maple Leaf Markets, Yellow Brick Road Casino, SavOns, and Point Place Casino. Participants who use their TS Rewards Card during the Promotion for non-gaming purchases will earn 100 bonus entries for every non-gaming transaction. No limit on the number of daily entries or bonus entries.

**Prize(s).** There are a total of five (5) prizes, one of which is the Grand Prize. The Grand Prize is a luxury, two-night weekend stay for two (2) people and includes the following components, [all which must be used during the two-night weekend stay] [Estimated Total Value of Grand Prize Package is \$12,222.50, which includes applicable sales tax]

The four (4) remaining Winners can select from one of the following overnight packages for two (2) people (blackout dates apply):

2. Drive & Dine Package (Estimated Max Value: \$781.76, which includes applicable sales tax)
3. Áhsi’ Day Spa Package (Estimated Value: \$478.37, which includes applicable sales tax)

**Prizes do not include any gratuities and will be the sole responsibility of the winner(s). Participants must be present at the live drawing at Turning Stone on August 29, 2018 to be eligible to win.**

All prizes awarded during the Promotion are non-negotiable, non-transferrable and cannot be exchanged for cash. No substitutions for package components by winner(s), or credit for unused portions of the package permitted. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses, including gratuities, are the sole responsibility of the prize Winner(s).

**Winning a Prize; Odds.** The 10 finalists will be selected in a random drawing of all entries from the entry database for a chance to win a chance to participate in the final drawing to win one (1) of the five (5) above prizes. The five (5) Winners will be selected from a random drawing of 10 finalists at a live drawing at Turning Stone. **The 10 finalists must be present at the live drawing at Turning Stone on August 29, 2018 to be eligible to win one (1) of the five (5) prizes.** Odds of being selected as a finalist depend on the number of eligible entries in the Promotion.

By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

**Claiming Prize(s).** The 10 finalists will be notified by email by August 27, 2018. The finalists will have 24 hours to reply to the email and confirm they will be attending the live drawing at Turning Stone on August 29, 2018. **If the finalist(s) fail to reply within 24 hours, the finalist(s) will forfeit and additional finalist(s) will be selected by random draw.** Turning Stone will not be responsible if the entrants' email address for their TS Rewards Card is missing or incorrect. At the live drawing, winner(s) will be notified by an announcement made during an event at Turning Stone. Winners must be present to win, and must claim their prize within 1 minute of the announcement. Turning Stone will not be responsible for failure of a participant to hear his or her name. If the winner(s) fails to present within the one-minute timeframe from when the announcement is made, the prize(s) will be forfeited and a redraw will occur until the prize(s) is awarded.

The Winners' prize overnight packages must be booked for a later date and cannot be redeemed on the date of the live drawing on August 29, 2018. The five (5) Winners will receive instructions at the live drawing for booking their weekend packages. All Winners' prize package weekends require advance reservations, depending on availability. Blackout dates apply. No compensation will be given for forfeited prizes. Valid photo identification must be presented when claiming all prizes. All winners are required to prove eligibility. **Release.** Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, employees and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

**Voluntary Participation.** Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use his/her name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

**Right to Cancel; Disqualification.** Turning Stone reserves the right to cancel the Promotion at any time. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified. Interference with this promotion includes the posting of any materials that are deemed inappropriate by Turning Stone. Inappropriate posts will be removed and the entry will be disqualified from the Promotion. Turning Stone may prohibit an entrant from participating in the Promotion or winning a prize if, in its sole discretion, it determines that such entrant is attempting to undermine the legitimate operation of the Promotion by cheating, hacking, deception, or other unfair playing practices or intending to annoy, abuse, threaten or harass any other entrants or Turning Stone representatives.
