



Official Rules for Flowering Points Multiplier Promotion (the “Promotion”)

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the “Promotion Site”) on Sunday, May 31, 2026 from 6:00am to 11:59pm (the “Promotion Times”). By participating, you agree to these Official Rules.

Eligibility. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age or older may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. Eligible participants will earn three (3) times the TS Rewards Points upon earning 150 points at the Promotion Site during the Promotion Times while using their TS Rewards Card. The entry must be activated by play on each participant’s slot machine. Use of TS Rewards Card during slot play is required to earn a multiplier.

Prize(s). For each one TS Rewards slot point earned during the Promotion Times there will be two bonus TS Rewards Points awarded, after a participant earns the qualifying 150 points.

Winning a Prize; Odds. All participants who qualify for the Promotion during the Promotion Times at the Promotion Site while using their TS Rewards Card will receive a TS Rewards Point bonus prize while playing on the slot machine. TS Rewards Point prizes are not the same as cash. Eligible participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s). By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). All applicable prizes won will be automatically added to the participant’s account.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary.
