



Official Rules for the In the Mow Promotion (the “Promotion”)

The Promotion will take place at Turning Stone Resort Casino, 5218 Patrick Rd., Verona, NY (the “Promotion Site”) and begins at 6:00am on Wednesday, April 1, 2026 and ends at 9:00pm on Friday, June 19, 2026 (the “Promotion Times”), with a drawing held at 9:00pm on June 19 (the “Drawing Time”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to adults who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. Eligible participants can receive one (1) complimentary entry each day of the Promotion by swiping their TS Rewards Card at any Promotional Kiosk and selecting the Free Entry tab located on the “Offers” screen of Promotional Kiosks. Promotional Kiosks are located throughout the Promotion Site. Complimentary entry will be automatically added to participant’s account upon selecting the Free Entry tab. Limit one (1) complimentary entry per participant per day during the Promotion. No wagers are needed to receive a complimentary entry and participants are limited to one complimentary entry per day during the Promotion Times. Use of TS Rewards Card is required to earn a complimentary entry. Eligible participants will earn one entry into the Promotion for every 10 slot points or 50 table points earned during the Promotion Times at the Promotion Site on a Promotional Day. Use of TS Rewards Card during slot or table play is required to earn an entry. Entries earned via slot play are automatically calculated. Entries earned via table play are calculated when rated table play has been completed and closed out at the table. Entries earned via table play will not be displayed if checked during an open table game session. Each participant’s entry totals may be viewed at any time via Promotional Kiosks. To view entries, participants must swipe their TS Rewards Card at a Promotional Kiosk and select the “Drawings” tab and then select the applicable drawing to view entry totals for the applicable drawing.

Activation. Entries for the Promotion must be activated. Eligible participants must activate their entries into the Promotion within one hour of the drawing on June 19, 2026 (the “Activation Periods”) by displaying active slot or table play while using their TS Rewards Card during the Activation Periods. If a participant fails to activate an entry within one (1) hour of the Drawing Time, the participant will not be eligible for that Drawing Time.

D (MSRP \$3,729.99) or \$3,500 cash prize, (ix) one (1) Summit GC38 S Grill Center (MSRP \$4,999.00) or \$4,000 cash prize and (x) one (1) Weber Summit FS38X S 5 Burner Natural Gas Wi-Fi Grill Stainless Steel (MSRP \$5,349.00) or \$4,500 cash prize. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. Winning a Prize; Odds. A total of ten (10) winners will be selected in a random drawing of activated entries from the Turning Stone earned entry database on June 19, 2026 at 9:00pm to play In the Mow! Game. Odds of winning depend on the number of eligible entries in the Promotion. There will be ten (10) lawn mowers game pieces on the In the Mow Game with each lawn mower game pieces representing one (1) of the ten (10) prizes. Each winner will select a lawn mower to reveal their prize. Winners will select lawn mower game pieces in order of arrival. Odds for prizes are 1:10 for each prize. Each winner can choose to receive the prize or they can choose the cash option for the prize they won. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Winner(s) will be notified of their selection in the random drawing by an announcement over the overhead speakers at the Promotion Site at the Drawing Time. The winners must present themselves at the Promotions Area in the Emerald Lobby within 15 minutes of the announcement. Turning Stone will not be responsible for the failure of a participant to hear their name. If the winner(s) fails to present within the 15-minute timeframe from when the announcement is made at each of the Drawing Times a redraw will occur. No compensation will be given for forfeited prizes. Valid photo identification and a valid TS Rewards Card must be presented when claiming all prizes. All winners are required to prove eligibility. All winner(s) will make arrangements at time of award to determine delivery of prize within three (3) weeks from award. Winners may be required to complete Form 1099 for prizes won.
