

Official Rules for Mr. Lucky's Best Buds Hot Seat (the "Promotion")

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the "Promotion Site") on Monday, April 20, 2026 from 1:00pm to 4:00pm (the "Promotion Times") with Hot Seat drawings at 1:00pm, 1:30pm, 2:00pm, 2:30pm, 3:00pm, 3:30pm and 4:00pm (the "Drawing Times"). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. To enter the Promotion, eligible participants must demonstrate active slot or table play and be using their TS Rewards Card during the Promotion Times at the Promotion Site to be eligible to receive prizes awarded during the Promotion.

Prize(s). A total of seven (7) \$250 cash prizes and up to fourteen (14) \$125 cash prizes will be awarded in this Promotion. One (1) winner will be randomly selected at each Drawing Time from the active player database at the Promotion Site to win \$250 in cash. There will also be up to one hundred and forty-seven (147) \$25 Free Play prizes awarded in this Promotion. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. All Free Play prizes will be awarded automatically and must be used within 48 hours of award. Failure to do so will result in forfeiture of prize. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. Winners chosen to play are randomly selected based on their location on the Turning Stone gaming floor. Odds of being selected to win depend on how many eligible guests are actively playing on the Turning Stone gaming floor while using their TS Rewards Card in active slot or table play during the Promotion Times. One (1) winner will be selected in a random drawing of entries from the active player database held at the Promotion Site, through a computer-generated report, at each of the Drawing Times on April 20, 2026. (Such winner, the "Cash Prize Winner") Each Cash Prize Winner will receive a \$250 cash prize. If a participant is playing at the same gaming bank or table as a Cash Prize Winner and at a machine or table position that is located either immediately to the left or to the right of the gaming machine or table position that Cash Prize Winner is playing on at the Drawing Time, such participant will receive a \$125 cash prize. There will be up to two (2) winners of \$125 cash prizes at each Drawing Time for a total of up to fourteen (14) \$125 cash prizes awarded during the Promotion. If there is no participant playing on the same gaming bank or table in a position immediately to the left or right of the Cash Prize Winner or if there is not a machine on the gaming bank or a table position that is immediately to the left or right of machine or table position the Cash Prize Winner was playing at the Drawing Time, then such \$125 cash prize will be forfeited and not awarded at that Drawing Time. If a participant is playing at the same gaming bank or table as the Cash Prize Winner (s) and at a machine or table position that Cash Prize Winner is playing on at the Drawing Time, such participant will receive a \$25 Free Play prize. There will be up to twenty-one (21) winners of \$25 Free Play prizes at each Drawing Time for a total of up to one hundred and forty-seven (147) \$25 Free Play prizes awarded during the Promotion. If there is no participant playing on the same gaming bank or table of the Cash Prize Winner or if there is not a machine on the gaming bank or a table position of machine or table position the Cash Prize Winner was playing at the Drawing Time, then such \$25 Free Play prize will be forfeited and not awarded at that Drawing Time. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Upon being selected, in accordance with the computer-generated report (drawing report), the individual chosen must be participating in active slot or table play and using their TS Rewards Card at the location displayed on the drawing report at time of prize award. Winner will be notified at their location on the drawing report by a member of the Promotions Team. Winner will be required to provide valid photo identification and a valid TS Rewards Card at time of award to receive any applicable prize. If the individual at the winner's location is not the same as the person denoted on the drawing report, does not have proper identification or is not actively playing with their TS Rewards Card at the time of award, they will be ineligible for the prize and the prize will be forfeited. Guests standing near the designated winner and/or "Winner Location" will not be considered eligible to receive prizes. Any unclaimed prize will be redrawn for a new winner and/or location. No compensation will be given for forfeited prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
