



## Official Rules for Prosperity Prize Wheel (the "Promotion")

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the "Promotion Site") on February 21, 2026 from 4:00pm to 7:30pm (the "Promotion Times") with Hot Seat drawings at 4:00pm, 4:15pm, 4:30pm, 4:45pm, 5:00pm, 5:15pm, 5:30pm, 5:45pm, 6:00pm, 6:15pm, 6:30pm, 6:45pm, 7:00pm, 7:15pm, and 7:30pm (the "Drawing Times"). By participating, you agree to these Official Rules.

**Eligibility.** Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

**How to Enter.** To enter the Promotion, eligible participants must demonstrate active slot or table play and be using their TS Rewards Card during the Promotion Times at the Promotion Site to be eligible to receive prizes awarded during the Promotion.

**Prize(s).** There will be fifteen (15) Free Play prizes awarded in this Promotion valued between \$88 and \$8,888. Prize value of each chosen participant will be determined by the spinning of the prize wheel at the Promotions Desk that contains thirty (32) slots, with each slot on the prize wheel representing the value of a Free Play prize. The prizes on the prize wheel will be: \$88 in Free Play, \$388 in Free Play, \$888 in Free Play and \$8,888 in Free Play. All prizes awarded during the Promotion are non-negotiable and non-transferable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. **Winning a Prize; Odds.** Winners of the prizes are randomly selected based on their location on the Turning Stone gaming floor. The odds of being selected depend on how many eligible guests are actively playing on the Turning Stone gaming floor while using their TS Rewards Card in active slot or table play during the Promotion Times. One (1) winner will be randomly selected, by a computer-generated report from the active player database at the Promotion Site, on February 21, 2026, at each of the Drawing Times to receive a Free Play prize for a total of fifteen (15) winners. Limit of one (1) winner per Drawing Time. The odds of the prizes on the Wheel will be: \$88 in Free Play (11:32), \$388 in Free Play (5:16), \$888 in Free Play (5:16), and \$8,888 in Free Play (1:32). By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

**Claiming Prize(s).** Upon being selected, in accordance with the computer-generated report (drawing report), the individual chosen will be notified by a member of the Promotions staff and the individual must be participating in active table/slot play, using their TS Rewards Card, in the location displayed on the drawing report at time of prize award. Winner will be required to provide valid photo identification and a valid TS Rewards Card at time of award to receive any applicable prize. If the individual at the winner's location is not the same as the person denoted on the drawing report, does not have proper identification or is not actively playing with their TS Rewards Card at the time of award, he/she will be ineligible for the prize and the prize will be forfeited. Any unclaimed prize will be redrawn for a new winner and/or location. No compensation will be given for forfeited prizes. All winners are required to prove eligibility. Winners may be required to complete Form 1099 for prizes won.
