

Official Rules for Senior Day U-Spin (the “Promotion”)

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the “Promotion Site”) on Wednesdays in March (March 4, 11, 18 and 25, 2026) from 6:00am to 11:59pm beginning on March 4 and ending on March 25 (the “Promotion Times” and each a “Promotional Day”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 55 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law.

How to Enter. Eligible participants who are at least 55 years of age will earn one (1) entry into the Promotion upon earning 55 slot points at the Promotion Site during the Promotion Times while using their TS Reward Card. The entry must be activated by play of a virtual game on each participant’s slot machine. Use of TS Rewards Card during slot play is required to earn an entry. Entries earned via slot play are automatically calculated and once an entry is earned, play of a virtual game is initiated when the participant selects the U-Spin tab on the participant’s slot machine, which appears after an entry is earned, during the Promotion Times on the slot machine the participant is playing at. Play of the virtual game is required for a chance to win one of the possible prizes. Limit one (1) entry per participant on each Promotional Wednesday, which must be activated on the Promotional Day earned and will not carry over to future promotional days if unused. Points earned are for the Promotional Day in which such points are earned only and do not carry over to future promotional dates. Points are only used as an entry mechanism and are not deducted from participant’s account for participation in the Promotion.

Prize(s). There are various prizes in the Promotion including TS Rewards Points valued at \$2.50 (250 Points), \$5 (500 Points), \$6 (600 Points), \$7.50 (750 Points) and \$25 (25,000 Points); and Free Play Prizes valued at \$5, \$6, \$7, \$10, \$11, \$25, \$50, \$100 and \$250. Not all prizes will have Free Play value. TS Rewards Point prizes are not the same as cash and the cash value assigned to the points here is for valuation purposes only. Prizes are awarded randomly at time of participation, and total number of prizes awarded depends on the number of eligible participants participating in the Promotion who earn the required number of slot points and activate and play the virtual game during the Promotion Times at the Promotion Site. All prizes awarded during the Promotion are non-negotiable and non-transferable. Eligible participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. All participants who qualify for the Promotion and earn the required number of slot points during the Promotion Times at the Promotion Site while using their TS Rewards Card will receive a prize upon completion of the U-Spin virtual game on the slot machine after selecting the U-Spin tab, which will be present on participant’s slot machine after earning an entry into the Promotion. The odds of winning each available prize are as follows: 250 TS Rewards Points (1:20), 500 Points (15,007:50,000), 600 Points (1:8), 750 Points (1:2,000), 25,000 Points (1:200), \$5 Free Play (11:40), \$6 Free Play (1:10), \$7 Free Play (37,499:500,000), \$10 Free Play (1:400), \$11 Free Play (50,311:1,000,000), \$25 Free Play (1:1,000), \$50 Free Play (3,769:250,000), \$100 Free Play (1:4,000) and \$250 Free Play (9:40,000). The prizes will be awarded at random by the U-Spin program during the participant’s play of the U-Spin virtual game. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). All awarded prizes will be displayed on the screen of the applicable slot machine at the completion of virtual game play. Any prize(s) won will be automatically added to the participant’s account. All Free Play prizes and TS Rewards Point prizes must be used within 48 hours of deposit. Failure to use any Free Play prizes or TS Rewards Point prizes within this 48-hour timeframe will result in forfeiture of such prizes. No compensation will be given for forfeited prizes. Turning Stone will not be responsible for failure of a participant to utilize any Free Play prize or TS Rewards Point prize within the allotted 48-hour timeframe.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, executives, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
