



Official Rules for Memorial Day Kiosk Promotion (the “Promotion”)

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the “Promotion Site”) on Monday, May 25, 2026 from 10:00am to 10:00pm (the “Promotion Times”). By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law.

How to Enter. Eligible participants will earn one entry into the Promotion upon earning 150 slot or table points at the Promotion Site during the Promotion Times on Monday, May 25, 2026. The entry must be activated by play of a virtual game during the Promotion Times at the Promotion Site. Use of a TS Rewards Card during active slot or table play is required to earn an entry. Once an entry is earned, play of a virtual game is initiated when the participant swipes their TS Rewards Card at a Promotional Kiosk at the Promotion Site and selects Memorial Day Kiosk Promotion tab during the Promotion Times. Play of the virtual game is required for a chance to win one of the possible prizes. Entries earned via slot play are automatically calculated. Entries earned via table play are calculated when rated table play has been completed and closed out at the table. Promotional Kiosks are located throughout the Promotion Site. Limit one entry per participant during the Promotion. Points are only used as an entry mechanism and are not deducted from participant’s account for participation in the Promotion. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Prize(s). There are various prizes in the Promotion including TS Rewards Points valued at \$5 (500 Points), \$10 (1,000 Points), \$25 (2,500 Points), \$50 (5,000 Points), \$100 (10,000 Points) and \$250 (25,000 Points); and Free Play prizes valued at \$5, \$10, \$25, \$50, \$100 and \$250. TS Rewards Points prizes are not the same as cash, and the cash value assigned to the points here is for valuation purposes only. Not all prizes will have Free Play value. Prizes are awarded randomly at time of participation, and the total number of prizes awarded depends on the number of eligible participants participating in the Promotion. All prizes awarded during the Promotion are non-negotiable and non-transferable. Eligible participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. All eligible participants who qualify for the Promotion (by earning the necessary slot or table points) will receive a prize upon swiping their TS Rewards Card at a Promotional Kiosk at the Promotion Site during the Promotion Times after earning the required slot or table points and playing a virtual game. The odds of each prize being awarded are \$5 Free Play (37:100), \$10 Free Play (1:20), \$25 Free Play (1:400), \$50 Free Play (1:4,000), \$100 Free Play (1:8,000), \$250 Free Play (1:8,000), 500 TS Rewards Points (19:50), 1,000 Points (1:20), 2,500 Points (1:800), 5,000 Points (1:4,000), 10,000 Points (1:8,000) and 25,000 Points (1:8,000).

Claiming Prize(s). All applicable prizes will be displayed on the screen of the applicable Promotional Kiosk at the completion of virtual game play and will be automatically added to the participant’s account. Free Play prizes are valid for 48 hours from the time of award, and failure to use any Free Play prize(s) within this 48-hour timeframe will result in forfeiture of these prizes. No compensation will be given for forfeited prizes. Turning Stone will not be responsible for the failure of a participant to utilize any Free Play prize within the allotted 48-hour timeframe.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, executives, team members and agents, harmless from all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use their name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.

Right to Cancel; Disqualification. Turning Stone reserves the right to modify or cancel the Promotion at any time without prior notice. Participants who do not comply with these Official Rules, or attempt to interfere or tamper with the Promotion in any way, will be disqualified.
