

Official Rules for the Bad Beats Dessert Coupon

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd, Verona, New York 13478 (the “Promotion Site”) and begins January 1, 2026 until December 31, 2026 (the “Promotion Times”). Must be present to win. One drawing and prize announcement will occur every Sunday at 6PM at TS Sports (Turning Stone Resort Casino location only).

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry who have made a parlay wager with any TS Sports location and lost such wager. Individuals with proper identification and who are at least 18 years of age may obtain a Turning Stone Rewards Card. Void where prohibited or restricted by applicable law. Employees, officers and directors of Turning Stone and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. After placing a bet at any TS Sports locations during the Promotion Times, including YBR Sports Book and Casino and Point Place Casino Hotel, participants may present their “bad beat” (losing parlay ticket(s)) to a TS Sports Book Writer located at Turning Stone Resort Casino, who will place it in a drum along with other losing parlay tickets. Each losing parlay ticket MUST have the participants’ TS Rewards number on it to be eligible for this Promotion. In order to ensure that the ticket has the participants’ TS Rewards number on it, at the time of placing the Parlay, the guest’s TS Card must be swiped (at the ticket writer terminal) or inserted and taken out (at the kiosk) for a card to be registered. The number will be printed on the top of the ticket.

Any and all “bad beats” (losing parlays) will be accepted between January 1, 2026 and December 31, 2026. Guests can put as many losing parlays in the drum during the Promotion Times, as long as the ticket has their TS Rewards number printed on top.

Turning Stone is not responsible for a participant’s failure to submit a ticket that does not include their TS Rewards Number, for tickets submitted after the end of the Promotion Times (i.e., after December 31, 2026), or for mutilated and/or otherwise illegible tickets that are submitted for a drawing. Every Sunday at 6PM Eastern Time during the Promotion Times, a TS Sports Book Writer will draw a ticket at random from the drum. The drawn ticket will be the winner of the day, and the winner may claim a free dessert coupon that can be redeemed at NY Rec & Social Club.

Prize(s). There are a total of 52 prizes to be awarded during the Promotion. The winner will be drawn at random from the drum every Sunday at 6PM by the TS Sports Team, with the last drawing occurring on Sunday, December 27th, 2026. The drawn ticket will entitle the winner to a free dessert coupon that may be redeemed at NY Rec & Social Club. The coupon expires 30 days after the date of the drawing. Both the date of the drawing and the expiration date of the coupon will be stated on such coupon. Participants who receive a coupon must use such coupons in accordance with any terms and conditions regarding such coupons. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

The coupon is valid and can be redeemed for 1 Skillet Cookie OR 1 Cheesecake from NY Rec & Social Club, valued at approximately \$10 (each).

Claiming Prize(s). The participant must provide their eligible bad beat (losing parlay ticket) to any TS Sports Book Writer to be placed in a drum along with other “bad beats.” The Winner will be drawn at random. The TS Sports management team will contact the winner Sunday evening by call or email based on the contact information listed in the guest’s TS Rewards profile. Winners will have 30 days to claim and use the coupon. Unclaimed coupons will be forfeited. Tickets that are not drawn from the drum will remain in the drum for future drawings for this Promotion. Odds of winning the prize(s) depend on the number of eligible entries in the Promotion. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion. Valid photo identification must be presented when claiming all prizes. All winners are required to prove eligibility.

The “bad beat” ticket will be kept/discarded Turning Stone to prevent re-use.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, employees and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary. By participating in the Promotion and accepting any prize, each participant grants Turning Stone, or its designee, permission to use his/her name, picture/likeness, address (city and state), biographical information, voice recording and any statements made by such participant regarding the Promotion or its business operations for promotional or publicity purposes without notice, further permission or compensation.
