Official Rules for the Parlay Playoff Promotion (the "Promotion")

The Promotion will take place at Turning Stone Resort Casino, 5218 Patrick Road, Verona, New York 13478, Point Place Casino, 450 Rt. 31, Bridgeport, New York 13030 and YBR Casino & Sports Book, 800 West Genesee Street, Chittenango, New York 13037 (the "Promotion Sites") beginning Wednesday, September 1 at 10am and ending at 12pm October 5, 2021 (the "Promotion Times"), with a drawing taking place on September 7, September 14, September 21, September 28 and October 5. Need not be present to win. By participating, you agree to these Official Rules.

Eligibility. Participation is open only to guests who are at least 18 years old as of date of entry who place a qualifying 3-Leg Parlay wager at the sports book located at one of the Promotion Sites (see How to Enter below). Participants must be TS Rewards members and use their TS Rewards Card to participate in the Promotion, including when placing a qualifying wager. TS Rewards Cards are free. Individuals with proper identification and who are at least 18 years of age may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Employees, officers and directors of Turning Stone, including YBR Casino & Sports Book, The Lake House and Point Place Casino, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. Eligible participants can earn entries into the Promotion by placing a 3-Leg Parlay wager of at least \$20 on any New York Professional Football Team on the September 1 – September 30 at the sports book at one of the Promotion Sites during the Promotion Times. In order to qualify for entry into this Promotion, the participant's parlay ticket must include a minimum of a \$20 - 3 Leg Parlay. The 3-Leg Parlay wager must be placed prior to 10pm on September 30 while using participant's TS Rewards Card. The 3-Leg Parlay is a single wager represented by one ticket that links together three wagers on the eligible New York Professional Football Team(s), which will only be a winning bet if all three choices selected are correct upon completion of game play. Participant's 3-Leg Parlay need not be a winning ticket to be considered eligible for entry into the Promotion and the drawing. Any wagers which are cancelled, refunded or voided are not eligible for entry into this Promotion. Participants may earn more than one entry if more than one 3-Leg Parlay bet is placed. Entry(s) will be automatically recorded in the sports wager database at the Promotion Site. Failure of a guest to enter or provide his or her TS Rewards Card number when placing the 3-Leg Parlay wager for this Promotion will render the wager ineligible for entry into this Promotion.

Prize(s). There are 25 \$100 TS Gift Card prizes in this promotion. All prizes awarded during the Promotion are non-negotiable and non-transferrable. Participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s).

Winning a Prize; Odds. Five winners will be randomly selected on September 7, September 14, September 21, September 28 and October 5 at 12pm from the combined 3-Leg Parlay Databases of all three Promotional Sites. Winners need not be present to win. Odds of winning the prize depend on the number of eligible 3-Leg Parlay wagers made in accordance with the Promotion and these Official Rules. By entering the Promotion, participants fully and unconditionally agree to be bound by these Official Rules and the decisions of Turning Stone, which will be final and binding in all matters relating to the Promotion.

Claiming Prize(s). Winners' names will be posted on The Lounge with Caesars Sports social media page and posted on Promotional Kiosks between 5pm on drawing date until 12pm the next drawing date. The winner's prize will be held at the Rewards Desk at Turning Stone until 5pm on the Tuesday following the applicable drawing for winner to claim. Turning Stone will not be responsible for failure of a winner to claim prize. If the winner(s) fails to claim their prize(s) within 14 days from the date the drawing is conducted, the prize(s) shall be forfeited. No compensation will be given for forfeited prizes.

Release. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s). By entering the Promotion, each participant and winner releases and holds Turning Stone and its parent organizations, affiliates and sponsors, and each of their respective representatives, officers, directors, employees and agents, harmless from any and all claims, losses, damages, costs and expenses of any kind in connection with the Promotion (including without limitation as a result of the acceptance, use of or inability to use any prize).

Voluntary Participation. Participation is voluntary.
